#### Convene

# **Budget Hearing**

John Mapes, Mapes & Miller Accounting was present for the 2025 proposed budget hearing for the County of Norton.

The first item of business was the hearing for the Revenue Neutral Rate. A motion was made by Commissioner Thompson to open the RNR hearing with a second from Chairman Beydler. Motion passed. #### Melissa Schoen, County Attorney

Melissa Schoen, Norton County Attorney delivered to the commission for review the "Settlement and Mutual Release Agreement" and the Agreement for Communication and Jail Service". The agreements are between the City of Norton and the County of Norton. The agreements were reviewed and will be discussed further when the Sheriff can be present.

## 2024 Appraisal Compliance

Commission reviewed a letter from David N. Harper, Director of Property Valuation Division,. Mr. Harper informed the commission by letter that the annual statistical and procedural compliance review for the 2024 appraisal year to determine substantial compliance within the county appraiser's office has been completed. A minimum of 75 point is required to successfully achieve substantial compliance and Norton County has met the criteria and is determined to be in substantial compliance.
