Convene

Commissioner Garrett Beydler called the meeting of the Norton Co Board of Commissioners to order at 9:00 AM on December 31, 2024 at the Commission Room. Attendance: Richard Thompson, Present; Garrett Beydler, Present; Marvin Matchett, Present.

NRP Hearing

Commissioner Matchett made a motion to open the NRP hearing with a second from Commissioner Thompson. Motion passed. Chairman Beydler open up the meeting to public comment. Present for the hearing was Alan Hale, Norton County Appraiser; Mindy Harting, Appraisal office; Abagail Horn, Norton County Attorney elect and Gene Carter. General discussion was held on the terms and agreement of the proposed NRP draft.
